Dear sirs,

The NINJA canopy commercialized by Parachutes de France is an extrem canopy reserved to highly experienced skydivers.

Various deflation occurrences have been reported to us. We impute them to the local air turbulences and incidents were avoided thanks to the good skills of the users.

We have no possibilities for controlling the customer skills and our company cannot take the risk generated by this canopy being used by neophyte or low experienced skydivers. Therefore, as precautionary measures, we have decided to ground all NINJA canopies.

We demand to NINJA owners to come into contact with our company as soon as possible.

We demand you to forward this letter and the included safety bulletin to all concerned persons.

We will keep you informed of our investigations and resulting actions.

We thank you in advance for your understanding and your cooperation.

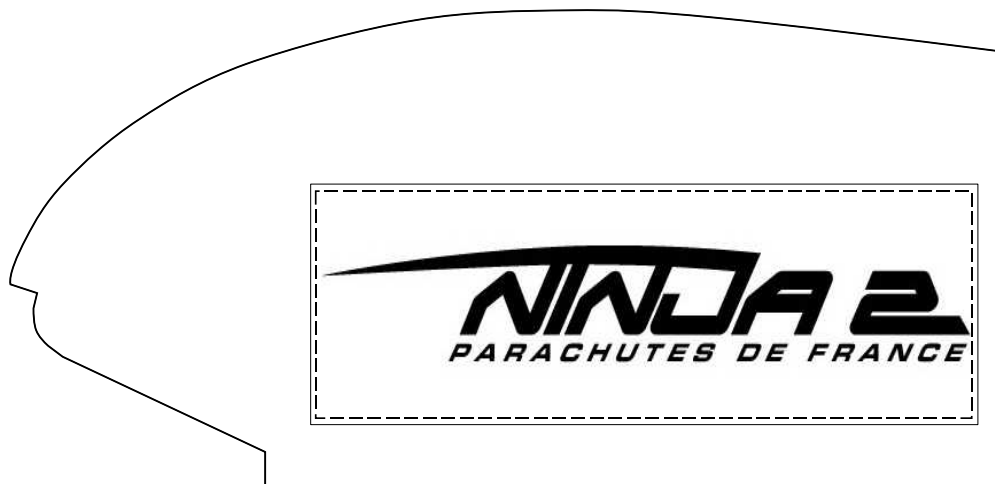
